

REGION II BYLAWS

IDAHO SCHOOL BOARDS ASSOCIATION

ARTICLE I-NAME AND PURPOSE

1. **Name:** The name of this association shall be IDAHO SCHOOL BOARDS ASSOCIATION REGION II.
2. **Purpose:** The adopted purpose of the IDAHO SCHOOL BOARDS ASSOCIATION shall be adopted as the purpose of REGION II and to do all things necessary to carry out those purposes.
3. **Conflict:** Nothing in these bylaws may be in conflict with the ISBA Bylaws, state or federal laws or any higher authority. Should such an event arise, this higher authority takes precedence over the lower and said item shall be null and void.

ARTICLE II -MEETINGS

1. The Regular Meeting of the Region II Association shall be held at the ISBA State Convention. The meeting at the ISBA State Convention shall be the annual meeting for the election of officers. Meeting notices shall be sent to superintendents and board chairpersons for all other special meetings.

2. Special meetings may be called by the Chair of Region II at the request of any member district.

ARTICLE III-OF FICERS

1. **Officers:** The officers of Region II shall be the Chair, Vice Chair, and Secretary-Treasurer. The Secretary-Treasurer shall be the Superintendent of the District from which the Chair is elected.

2. **Duties:** duties of the Chair shall be to arrange meetings, appoint any necessary committies and preside at the meetings of the Regional Association. In addition, the Chair shall keep the regional membership fully informed by means of newsletter or other appropriate means as to the pertinent activities of the Region and State organizations. The Vice Chair shall assume these duties in the absence of the Chair.

3. **Terms:** Upon completion of the term of office or in case of vacancy in the office of Chair, the Vice Chair shall succeed to the office of Chair. The Chair shall fill a vacancy in the Vice Chair by appointment, with the appointee serving until the

next annual meeting when a person shall be elected to complete the term.

4. **Alternate Terms:** The Chair and Vice Chair shall serve as regional representatives to the Executive Board of ISBA and represent both large and small districts. These offices shall alternate. Determination of large and small districts shall be made at the annual meeting at the ISBA Annual Convention on the basis of immediate past enrollments. The dividing line shall be established on the medial as prescribed herein:

Of the fifteen (15) member districts, the eight (8) with the smallest enrollment shall be considered small districts; the seven (7) with the largest enrollment shall be considered the large districts.

5. **Alternate:** An alternate representative to the Executive Board may be APPOINTED by the Chair to ensure full regional representation on the Executive Board.

6. **Election and Term of Office:** Election of Region II officer(s) shall take place in even-numbered years. Term of office for Chair shall be TWO YEARS. The Vice Chair will automatically become Regional Chair following their term as Vice Chair. Officers shall assume office with the installation of executive officers at the state convention of year elected.



2. Proposals for bylaw changes may be made by any duly elected or appointed trustee of Region II holding membership with Idaho School Boards Association Region II.
