Authorization to Release Information on Past Job Performance / Related Conduct

I wish to be considered for employment, in the position of **Superintendent**, with **Bonneville Joint School District No. 93**. I understand that as a part of the applicant process, the school district is required by **Idaho Code 33-1210** to request that the applicant sign a release statement authorizing the applicant's current and past employers, including employers outside the state of Idaho, to release to the school district all information relating to the job performance and/or job related conduct, if any, of the applicant and making available to the hiring school district copies of all documents in the previous employer's personnel, investigative or other files relating to the job performance by the applicant.

I also understand that Idaho Code 33-1210 (b) releases the applicant's current and past employers, and employees acting on behalf of that employer, from any liability for providing information described in paragraph (a) of this subsection, as provided in subsection (4) of this section. *A school district shall not hire an applicant who does not sign the statement described in subsection (2) of this section.*
