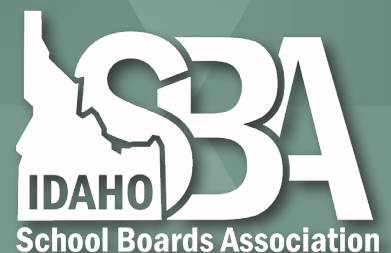

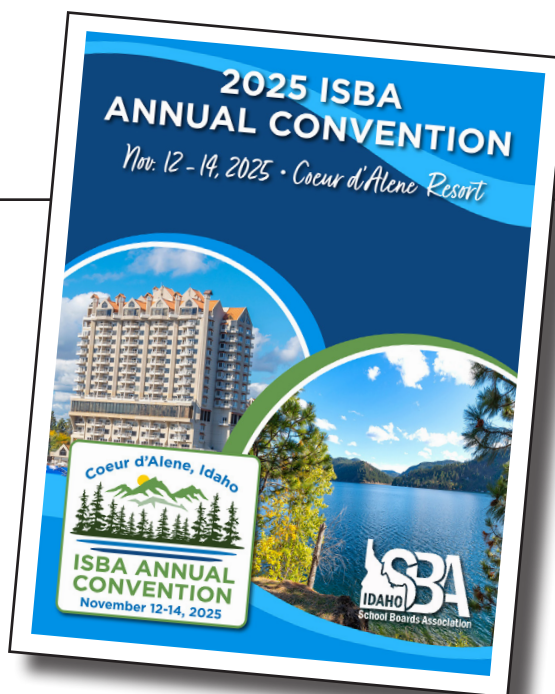

About the SLATE

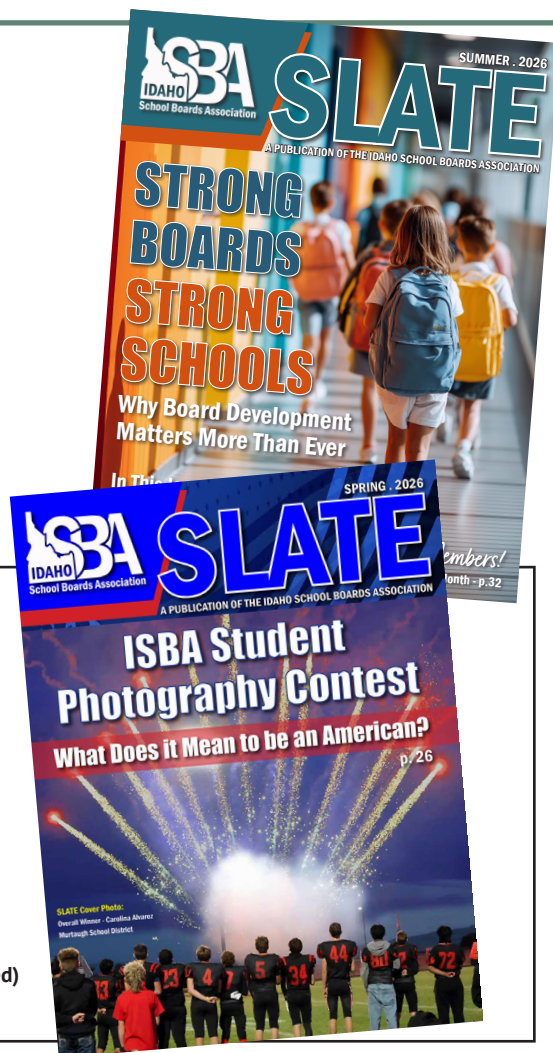
