Mock Board Meeting

Nothing could possibly go wrong at our meeting tonight, right? Think again! Remember that people are watching. Join us for an interactive board meeting to develop strategies to promote positive board behavior and preparedness. We will discuss who sets the agenda, how to handle public participation, meeting minutes, motions, debate, and voting.

Authorizing from the Charter School's Perspective: A Collaborative Approach

The National Association of Charter School Authorizers (NACSA) promotes 12 Essential Practices for authorizers in order to support and foster high-quality charter schools. In this session, we'll discuss how charter schools can use these practices to improve their relationships with their authorizers, impact student achievement, and improve governance. Come prepared to share your experiences, learn from your colleagues, and rediscover the importance of your leadership at your charter school!

The Board's Role: Oversight vs. Overstepping

The board member serves in the oversight role for the district/charter. This critical role includes many facets and there can be confusion about what it means, what its requirements are, and the difference between oversight and other roles. This workshop will help the board member, superintendent/administrator, and other staff to understand the role of the board in the district/charter. This workshop will look at the line between oversight and overstepping as well as the legal consequences associated with overstepping.

Building Trust; A Community Approach to School Facilities, Bonds, and Levies

This session will focus on one of the most complicated areas of schools; school facilities. The struggles are unique in each district throughout the state. Resources are limited, buildings are aging, or the district does not have the facilities needed to accommodate its current growth. Each of these needs requires the Board's attention. We will talk about funding construction on renovations, updates, and new facilities as well as what that means to your community and your role in that process. School construction has become a big-ticket item, and we want to make sure our districts have the knowledge needed to make decisions that will positively impact their students, teachers, parents, and communities.
