The 2019 Late Summer Policy Update Release includes the following new or revised policies.

Description of Update:

Board of Trustees

1260 Authorization of Signatures: ISBA routinely receives questions about what it means to “certify” an invoice, so the update clarifies this, changing it to “approving” an invoice instead. Furthermore, the changes under the “checks” portion reflect the requirements of Idaho Code. **This is an optional policy.**

1500 Board Meetings: This language is reflective of changes outlined in House Bill 150 and went into effect on July 1st. Please note that this change to executive session **only** applies when you have two or more vacancies, and does not apply if board members are simply absent. **This is a highly recommended policy.**

1610 Trustee Conflict of Interest: We struck one section of the policy that many felt was redundant and raised more questions than answers. **This is a highly recommended policy.**

1620 Board Goals and Objectives: This strikes the word "executive" session, as holding an executive session would likely not apply to setting board goals and objectives which should be held in open session. **This is a recommended policy.**

Instruction

2335 Digital Citizenship and Safety Education: We received many questions about the stricken-out section that outlines that instruction will be given to students “at the secondary level”, which the law does not state. **This is a required policy.**

2435, 2435F Advanced Opportunities: These are changes from the 2019 Legislative Session and include updates to how advanced opportunity or “fast forward” dollars may be used in your school. **This is a recommended policy.**

2700PHigh School Graduation Requirements: There have been some significant changes to Idaho’s graduation requirements as well as a new ability for your students to apply for a “flexible schedule,” if they meet certain criteria. As always, these are minimum requirements for graduation and the school may add additional requirements. **This is a recommended policy.**

Students

3285 Relationship Abuse and Sexual Assault Prevention and Response: This is a minor change to a reference. **This is a required policy.**

3290 Sexual Harassment Intimidation of Students: This is a minor change to a reference. **This is a recommended policy.**

3296 Bullying Awareness Week: This is a minor change to a reference. **This is an optional policy.**

3450F Student Vehicle Parking: This is a recommended update to the Student Vehicle Parking Application as suggested by ISBA's legal counsel. **This is a highly recommended form if you have student parking.**

Community Relations

4120 Uniform Grievance Procedure: This update now includes a process for cases in which the person designated to hear a grievance is the subject of the grievance. **This is a required policy.**

4150 Accommodating Individuals with Disabilities: This is a minor change to a reference. **This is a required policy.**

4530F Crowdfunding Request Form: ISBA released a corresponding policy in the late Spring 2019 update. This form accompanies that policy. **This is an optional form.**

Personnel

5250 Certificated Staff Grievances: Like the update to the Uniform Grievance Procedure, this update addresses cases in which a person designated to hear a grievance is the subject of the grievance. **This is a highly recommended policy.**

5275 Adult Sexual Misconduct: This is a new policy to guide administrators and educators on addressing adult sexual misconduct in the school setting. **This is a recommended policy.**

5395 Whistleblowing: This is a new policy which outlines a process for when school employees know, or have reasonable cause to believe, that wrongful conduct has occurred within the school. **This is a recommended policy.**

5750 Employing Retired Teachers and Administrators: This update ensures that when a charter school hires a retired teacher or individual that they have followed the proper steps to avoid paying any penalties to the PERSI system. **This is a highly recommended policy.**

Financial Management

7400 Miscellaneous Procurement Standards: This update corrects an error to a reference that arose as a result of the 2019 Late Spring Update.

Noninstructional Operations

8170P School-Owned Vehicles: These are minor updates that provide clarification related to school-owned vehicles. **This is an optional policy.**
