The Boise-Nampa metropolitan area, also known as the Treasure Valley, has a combined population of 709,845, the most populous metropolitan area in Idaho. Boise is the 80th most populous metropolitan statistical area in the United States.

Downtown Boise is the cultural center and home to many small local businesses. The area has a variety of shops and dining choices. The city has many local restaurants, bars, and boutiques and supports a vibrant nightlife. The area contains the Basque Block, which showcases Boise's Basque heritage. Downtown Boise's main attractions include the Idaho State Capitol, the classic Egyptian Theatre, the Boise Art Museum, and Zoo Boise on the grounds of Julia Davis Park.
