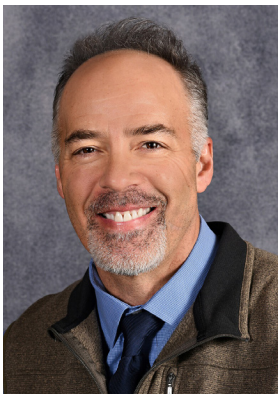

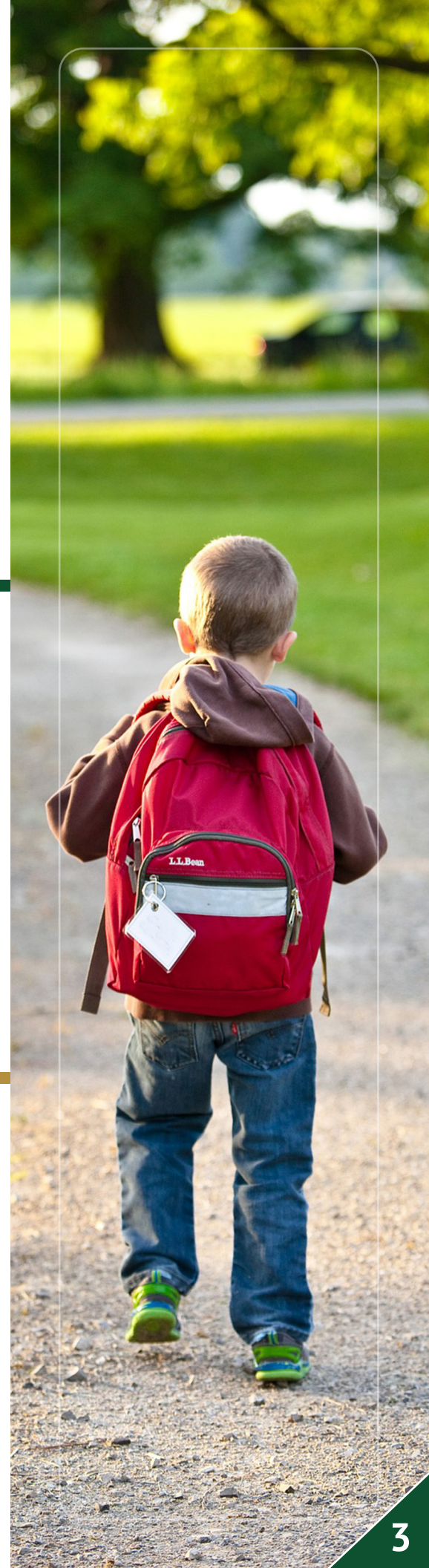
ISBA Mission: The mission of the Idaho School Boards Association is to provide leadership and services to local school boards for the benefit of students and for the advocacy of public education.

Advocacy



ISBA advocates on behalf of school boards year round, and provides the tools you need to influence public policy for the benefit of public education.

As a service for school districts and charter schools, ISBA Legislative Services staff works with legislators, the State Board of Education, the State Department of Education, and the Governor's office, as well as other education stakeholders in developing education legislation, as directed by the membership. We also oppose bills that restrict local control of schools.. ITo advocate for school districts and charter schools, the ISBA staff and Government Affairs Committee are involved in day-to-day activities at the Legislature.

Business Session

The Business Session is one of the most important functions held at ISBA's Annual Convention. It provides members with the opportunity to direct the Association and its major policies. During the Business Session, school board members get to vote on ISBA resolutions and bylaw changes.

Legislative Update Webinar

The ISBA Legislative team provides live webinars during the session to give members timely updates and on relevant education policies.

Fall Region Meetings

Each September, ISBA holds regional meetings where members get a firsthand look at proposed ISBA resolutions that they will vote on in November.

Government Affairs Committee (GAC)

ISBA staff works closely with the Government Affairs Committee. The GAC is comprised of the ISBA Executive Board Officers and Region Chairs. There is an equal number of large districts and small districts represented on the GAC. The committee reviews ISBA resolutions and makes recommendations to staff during the legislative session, both relating to ISBA resolutions and legislative issues that may arise that are not covered by ISBA resolutions.

Capitol Notes

During the legislative session, ISBA sends out a weekly newsletter to keep our members up to date on all the education issues at the Idaho Legislature. Members can find a comprehensive list of all education bills and their status at the end of Capitol Notes.

Calls to Action

During the legislative session, ISBA will send out ISBA Action Alerts to have you contact your legislators or legislative committee members, regarding urgent issues that impact your school or district.

Day on the Hill

Every year, ISBA hosts our Day on the Hill event. This provides our members with the opportunity to experience the legislative process firsthand by sitting in House Education and Senate Education Committee meetings as well as have lunch with legislators.



Professional Development

The Idaho School Boards Association strives to provide school board members with the information, professional development, and support needed to serve their district or charter school. Developing highly trained and effective board/superintendent-charter administrator teams will help to positively impact student achievement and success. Board members are encouraged to participate in ongoing professional development so they continue to gain knowledge and skills that can be applied to their service as a school board member.

The Legislature appropriates \$6,600 per school district or charter school to be used specifically for board, and superintendent/charter administrator training each fiscal year. ISBA is an approved trainer, which means the state will reimburse up to \$6,600 of approved professional development expenses for each fiscal year for qualified topics. In addition, ISBA provides support for completing the reimbursement form to the Idaho State Department of Education for the workshops that meet the guidelines.

Professional Development Workshops

ISBA has created professional development workshops to accommodate our members' needs. Topics include: superintendent or charter administrator evaluations, finance, ethics, governance, strategic planning, and continuous improvement. Also, customized workshops can be created for individual board needs. Some of our top requested workshops are:

- **Board Basics** – covers general governance, including an overview of roles and responsibilities, board norms and protocols, and board meeting basics. Whether your board has new or veteran board members, this training will benefit all.
- **Roles & Responsibilities** – goes deeper into the different responsibilities of the board and superintendent/charter administrator in eight areas.
- **Board Norms & Protocols** – facilitation of identifying areas that would benefit from the development and/or revision of norms and/or protocols so the board can run efficiently with a focus on the mission and vision of the board.
- **Superintendent/Charter Administrator Evaluation** – provides ISBA's superintendent/charter administrator evaluation tool that includes indicators and rubrics. Covers the five-step process for evaluation of superintendent/charter administrator that not only meets the requirements of Idaho code, but also provides an accurate, fair and substantive evaluation which is the most significant lever a school board has to drive improvement.
- **Strategic Planning** – assists your board, superintendent/charter administrator, and leadership team, if applicable in developing a long-term, typically five-year, strategic plan. The benefits of a strategic plan are creating a focus for the superintendent/charter administrator, and a way to measure progress of the identified goals.
- **Continuous Improvement Plan** – Idaho code requires all boards to approve and monitor an annual continuous improvement plan. This professional development assists your board in creating, revising, aligning, implementation and monitoring of the continuous improvement plan.kj

ISBA New Board Member Packet

The new board member packet also equips newly elected school board members with essential tools and resources for their first year. This comprehensive packet includes foundational materials like governance basics, parliamentary procedure guides, and boardsmanship tips. It also features key documents such as a welcome letter, a district and charter school map, education glossaries, and insights into effective board membership. Designed to ensure confidence and success as a new school board member.





Policy Services

Policy Update Service

A primary function of ISBA is to support and improve policy-making by Idaho's public school boards. The Policy Services staff provide reliable, authoritative policy assistance and information to help school boards draft and maintain policies. ISBA Policy Staff help schools update their policies based upon changes in legislation. Most Idaho school districts and many charter schools are members of the Policy Update Service. This year ISBA released the first official Charter School Policy Manual.

Policy Rewrite

ISBA offers three options to assist districts and charter schools with their policy manual needs. They are:

1. **Blended Policy Manual Rewrite.** ISBA customizes each model policy, blending it with existing district or school policies.
2. **Fresh Start Policy Manual Rewrite:** This allows the school district or charter to purchase an ISBA Model Policy Manual customized with the district's or charter's information and further customized with help from ISBA.
3. **Purchase Model Policy Manual.** We have separate model policy manuals tailored to meet the needs of school districts and charter schools.

Legal Services

Each member school district or charter school is entitled to four hours of prepaid legal time per fiscal year. This allows members to contact Anderson, Julian & Hull for help with complicated legal questions or other services such as policy, contract drafting or review, or negotiations advice. Members are able to allocate their legal time as they see fit and without regard to topic. By getting accurate legal advice upfront, ISBA members can often avoid costly litigations down the road.





Other Services

Member Consultation

ISBA strives to be a leader on education issues. The ISBA staff is available to consult by telephone with school districts, charter schools, or individuals on a broad range of education topics.

Insurance

One of the key benefits of ISBA is the option to use the ISBA Property and Liability Insurance Plan through Moreton & Company which is only available to ISBA members. The ISBA Insurance Plan helps school districts and charter schools meet their insurance and risk management challenges. One benefit of this program is the opportunity for participating districts and charters to receive dividends based upon the claims experience of the group. Over 75% of Idaho school districts and charter schools are now enrolled and have received over \$7.6 million in dividends.

Superintendent Searches

ISBA understands the selection of a superintendent or charter school administrator is one of the most important decisions the board will make. ISBA offers professional services to school boards seeking to fill a superintendent or administrator vacancy. ISBA has assisted with 20 superintendent searches in the past four years. This service includes any or all of the following: promoting the position opening nationwide, reviewing application packets, conducting reference checks, providing the board with sample interview questions, assisting the board with the interview process, and more.

Ask ISBA

ISBA staff receives questions from board members, superintendents, and clerks on a variety of topics. To help others learn from these questions and answers, ISBA offers the Ask ISBA service on its website. Members can submit their question online and also review an archive of previously asked questions and answers.

Labor Relations

ISBA Job Descriptions Manual

We heard from many school districts and charter schools that having a resource for model job descriptions would be a great benefit. From superintendent to custodian, the ISBA Job Descriptions Manual will provide qualifications, reporting structures, scope of responsibilities, and more for the many jobs in your district or charter school. You'll be able to simply customize each sample description to meet your needs.

Salary Schedule

Each year the ISBA compiles salary schedule and benefit information from Idaho school districts and charter schools to create the Salary Schedule. This schedule is offered in electronic format to all members as part of their membership dues.

Master Agreements

Salary Schedule

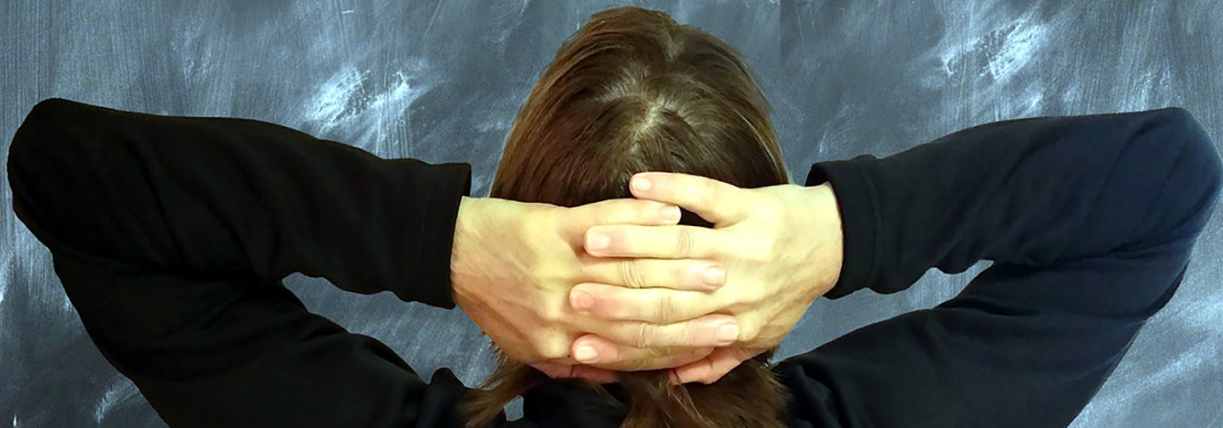
